25 No Rupiyabathan Gaon Panchayat, Vill- Rupiyabathan, P.O – Chamata, PIN-781306, Paschim Nalbari Dev Block collects non-biodegradable waste from the college, hostels, and staff quarters to shredding units for recycling as per the collection calendar of the Government of Assam. The waste is segregated into different sections based on its features.

The FIRST party and SECOND party have made this Memorandum of Understanding for Waste management under following terms and Conditions-

1. To facilitate the collection and transportation of solid waste, e-waste from the college, which is a vital element in the protection of the environment. Whereas Kamrup College has agreed to give away the e-waste, solid wastes of plastic, paper and glass generated in the college. The collection of these recyclables from Kamrup College, Chamata will be initiated as per schedule, where both the parties agreed mutually.
2. The MoU will be Valid for a period of 5(five) years before renewal.
3. **TERMINATION**:- Either Party may terminate this MoU by providing written termination notice of its intention to terminate the MoU to the other party.
4. **MODIFICATION**:- The parties may change or modify the terms and this agreement only by written amendment signed by both the parties.
5. **SETTLEMENT OF DISPUTES**:- Any disputes concerning interpretation and application of this MoU shall be settled amicably through consultation or negotiation between the parties. In witness whereof the Parties here to duly executed this presents on the day, month and year herein above first mentioned.

DEFINED TERMS IN THIS AGREEMENT

Solid Waste: Plastics, wood, metals, glass, leather, sanitary waste in septic tanks and other wastes. **E-waste:** electrical and electronic equipment which Includes-Computers & Peripherals (CPU, Keyboard, Mouse& Monitor) b. Laptops, **Paper Waste:** Discarded paper including cardboard, newspaper, magazines, shredded paper, office records, notebooks, etc. **Plastic waste:** Polythene shets, carry bags, bottles, bottle caps, food wrappers, dust bin papers straws and stirrers, etc. **Glass waste:** Bottles, bottle caps, bulbs, jars, etc.


