II. Daffodil College of Horticulture

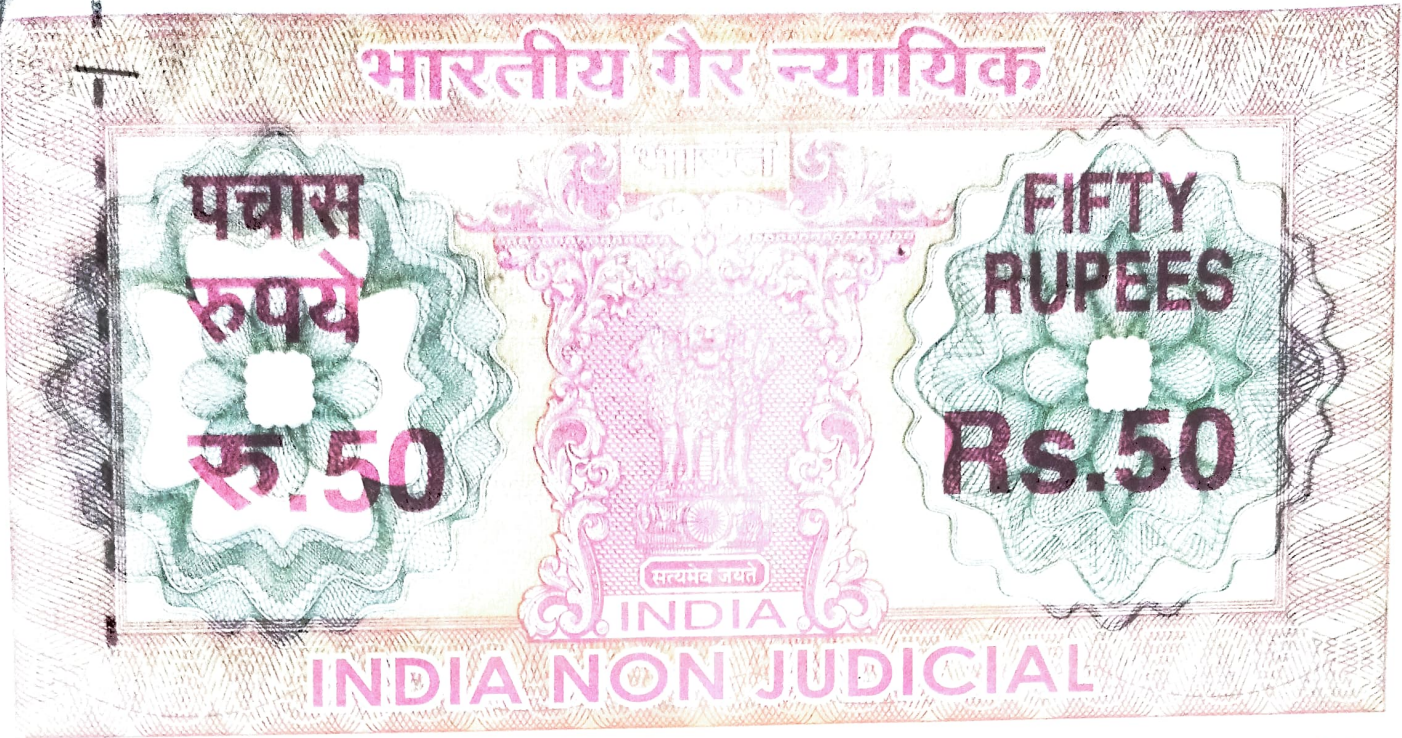

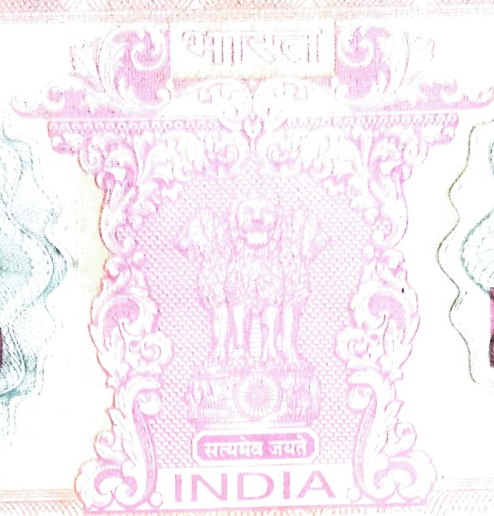

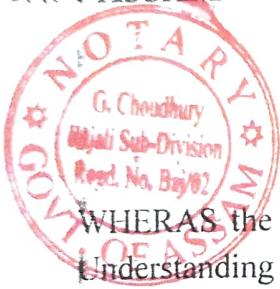

NOW THIS MEMORANDUM OF UNDERSTANDING WITNESSETH AS FOLLOWS :

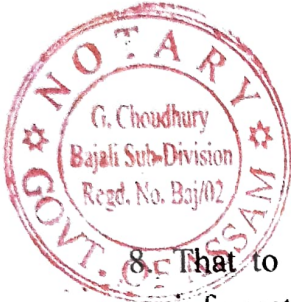
1. That to organize orientation lectures for overall development of students and teachers.

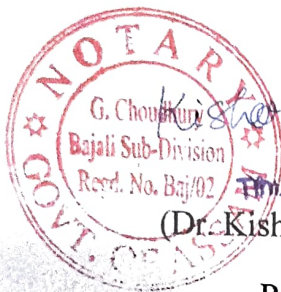
