- 6. That to undertake students' internships based on academic requirements.
- 7. That to publish research books, book chapters, general publication media and other academic journals in collaborative mode between the teachers.
- 8. That to use mutual learning environment as a platform for providing information and communication technology.
- 9. That the students will be made to comply with the policies of both the institutions.
- 10.That to utilize the library resources of both the colleges by students and teachers. Principal Chamata College, Kamrup
- 11. That to organize extension education programmes in collaborative mode for the benefits of the students.
- 12. That the MoU will be valid for a period of 5(five) years before renewal.
- 13. **Termination**: Either party may terminate this MoU by providing written termination notice of its intention to terminate the MoU to the party.
